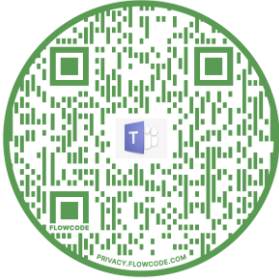

## “Coma and Neurological Prognostication”
